### **Licensed electronic money institutions in Liechtenstein**

The Register of Electronic Money Institutions, their agents and branches is maintained under Article 36 Law of electronic money (Electronic Money Act).

Electronic money institutions which are in possession of a license according to Art. 4 Law of electronic money are subject to the prudential supervision of the Financial Market Authority Liechtenstein (FMA).
