

## **Payment Services Register pursuant to Article 16 of the Payment Services Act (ZDG)**

### **1. Authorized Payment Institutions in Liechtenstein**

The following payment institutions have a licence pursuant to Art. 7 ZDG and are under the ongoing supervision of the Liechtenstein Financial Market Authority.

### **2. Registered account information service providers**
